## 1. Dimestore Fisherman/KDCDC:

The municipality has secured \$5000.00 of funding from KDCDC. This will offset half of the costs to bring The Dimestore Fisherman television program to Matachewan to help enhance the tourism industry of this community.

Council discusses inviting the local tourist resorts and if needed the Young Davidson Mine to share in the remaining \$5000.00 cost of bringing the program here as well as providing; gasoline, 2 boats, food and lodging. Letters are to be sent to; Golden Eagle, Camp Matachewan, Horseshoe Island Camp, Christie's Camp and maybe Dogstar Services after a conference call with the program producer.

It is decided that the week leading up to July 1, 2010 will be when Matachewan will host the program. The office staff is to schedule a conference call with Jim Hoey on February 3, 2010 at 3 p.m. to discuss the process in more detail. This conference call must be scheduled prior to sending letters to the local tourist businesses in order to clarify what their involvement may be.

## **BCF Water Project:**

Council discusses the difference between the project proposals from TROW and AECOM and notes that there is a \$69,000.00 difference between the two proposals once OCWA has adjusted TROW's proposal to include items that were not included in their proposal. OCWA has included these costs in order to anticipate any extras that this company may attempt to include in the future if chosen.

Councillor Bisson presents his comparison between proposals, their project structure and financial breakdown and he compares their technical differences.

OCWA has suggested that Andrew Van Oosten and Council interview both candidates.
